19/02 Declarations of Interest : None declared

19/03 Previous Minutes - ACTION : Clerk to re-circulate draft November minutes for comment.

19/04 DA/2018/1077 : Outline application for construction of 4 No. single storey linked units for light industrial purposes and associated parking at Mill Hill Farm, Hothorpe, Marston Trussell, Northamptonshire, LE16 9TX – It was **RESOLVED** to **SUPPORT** to the application provided strong consideration was given to the condition of the road in which would act to serve as the only access to the development. Reference was made to the Highway Authority's comments provided in DA/2011/1020 in which it states 'Should the local planning authority grant planning permission on this current application; and to include the above Conditions; it must be noted that the local highway authority will not support any further development of the application site due to the substandard nature and width of the remaining length of Theddingworth Road.' We therefore request that consideration is given to prevent any large increase in traffic and further damage to the roads serving the development.

They advised they have never released money to a Parish Meeting before and would therefore need to seek legal advice before advising of the next steps. A number of projects were discussed.

- The Village Hall has a grant application in to allow toilets to be installed, which is pending.
- The area in front of the church which is used for informal parking could be upgraded to allow this to be used without creating further damage to the verge.
- Installation of central heating in the Church
- A village sign e.g 'Welcome to Marston Trussell'

It was **RESOLVED** to propose to DDC that the money be used in order to re-develop the hardstanding at the front of the Church. **ACTION :** Clerk to contact DDC re project and NCALC for guidance.
